F & E Dispursing money before it gets recalled to general fund. \$138,000 to 51 DAA (70\$ of Allocation). This is the last amount of money they will get.
- State Budget: if it passes today, then F & E may get partial funding again. Not \$32 million but 10 to 15, 000,000.**
- CDFA – independent agreement with each fair.**
- 48th – Dan met on May 30th If the 48th DAA and the 51 DAA could combine, including money, it could guarantee long term survival. Question was raise as to how the two would operate. R. Desmond is meeting with the 48th DAA tomorrow to explain the future of airs and where they stand.**
